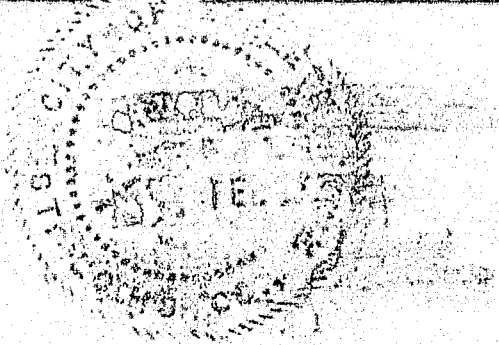

ORDINANCE NO. 112

AN ORDINANCE ANNEXING CERTAIN PART OF SOUTHEAST QUARTER OF THE
NORTHWEST QUARTER (SE $\frac{1}{4}$ OF NW $\frac{1}{4}$) OF SECTION TWENTY-NINE (29),
TOWNSHIP FIFTY-EIGHT (58) NORTH, RANGE SEVENTEEN (17) WEST

The City Council of the City of Eveleth do hereby ordain,
as follows:

Section 1. That part of the Southeast Quarter of
the Northwest Quarter (SE $\frac{1}{4}$ OF NW $\frac{1}{4}$) of Section
Twenty-nine (29), Township Fifty-eight (58) North,
Range Seventeen (17) West:

Beginning at the southeast corner of said Southeast
Quarter of the Northwest Quarter (SE $\frac{1}{4}$ of NW $\frac{1}{4}$),
Section Twenty-nine (29), Township Fifty-eight (58)
North, Range Seventeen (17) West; and going North
89 degrees, 24 minutes, 30 seconds West along the
Quarter line for a distance of 444.88 feet to the
point of beginning; thence going North 89 degrees,
24 minutes, 30 seconds West along the Quarter line
for a distance of 250 feet to the State Highway
No. 53 Right of Way line; thence going in a
northerly direction along said Highway No. 53
Right of Way line for a distance of 300 feet;
thence going South 89 degrees, 24 minutes, 30
seconds East for a distance of 250 feet; thence
going South for a distance of 300 feet to the
point of beginning; comprising an area of 1.72
acres more or less,

shall be and it hereby is declared to be an addition to the
City of Eveleth and shall become part of the City of Eveleth
as effectively as if it had been originally a part thereof.

Section 2. This ordinance shall be in full force
and effect from and after its passage and publication.
