Writ of election providing for the filling of a vacancy in the office of State Representative from the East One-half of the Thirtieth Legislative District at a special election to be held on March 27, 1965, and providing for nomination of candidates for said vacancy at a special primary election to be held on March 13, 1965.

To the people of the State of Minnesota and particularly of the East one-half of the Thirtieth Legislative District of said state; To the Secretary of State of the State of Minnesota; To the County Auditor of the County of Hennepin in said state; To all election officers in the East one-half of the Thirtieth Legislative District, and all of the several election districts therein; and To All Others whom it may concern:

WHEREAS the House of Representatives has declared that a vacancy exists in the office of State Representative from the East one-half of the Thirtieth Legislative District of the State of Minnesota; and


WHEREAS the State Legislature is now in session and the person elected to fill said vacancy will have occasion to take office and exercise the functions thereof immediately after his election;

NOW, THEREFORE, I, KARL F. ROLVAAG, AS GOVERNOR OF THE STATE OF MINNESOTA, acting under the authority and direction of Section 17 of Article IV of the Minnesota Constitution and the




statutes in such case made and provided, do hereby direct that said vacancy be filled at a special election to be held in said district on Saturday, the 27th day of March, 1965, and that candidates for said office be nominated at a special primary election to be held in said district on Saturday, the 13th day of March, 1965; that affidavits of candidacy for nomination at said primary may be filed on and between the 3rd day of March, 1965 and the 8th day of March, 5:00 P.M., 1965, both dates inclusive; that notices of said primary election and the said election thereafter be given, posted, and published as prescribed by law; and that the nomination and election of candidates and the conduct of said elections be had, and all things pertaining thereto be done, as provided in Minnesota Statutes, Sections 203.44 to 203.56, and other applicable provisions of law.

IN WITNESS WHEREOF I have hereunto set my hand and caused the great seal of the State of Minnesota to be hereunto affixed at the Capitol in the City of St. Paul, Minnesota, this 1st day of March A.D., 1965.
