ORDINANCE NO. 26

AN ORDINANCE PROVIDING FOR THE ANNEXATION  
TO THE VILLAGE OF HACKENSACK OF CERTAIN  
LANDS IN SECTIONS 19 AND 30 OF TOWNSHIP  
140, RANGE 30.

WHEREAS, a petition has been presented to the village council of the Village of Hackensack, Minnesota, signed by all of the owners of the following described premises in Cass County, Minnesota, to-wit: South Half of Southeast Quarter (S $\frac{1}{2}$  of SE $\frac{1}{4}$ ) of Section Nineteen (19) and the Northwest Quarter of Northeast Quarter (NW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Thirty (30), all in Township One hundred forty (140), Range Thirty (30), asking that said premises be annexed to the Village of Hackensack, Minnesota; and,

WHEREAS, due and proper notice of said proposal was given as required by law, and no objections filed in opposition to said proposition; and,

WHEREAS, it appears to the satisfaction of said village that said tract is less than 200 acres in area and it abuts upon the village limits of said village, is urban in character and properly the subject of village government, and that said petition was signed by all of the owners of the tract proposed to be annexed; and,

WHEREAS, the council deems it to the best interests of said village and of the territory affected that said territory be annexed to said village; and

WHEREAS, the said village council has by resolution duly passed decided to grant said petition:

NOW, THEREFORE, the village council of the Village of Hackensack, Minnesota, does ordain as follows:

Section 1: That the following described lands abutting upon the corporate limits of said village, and not exceeding 200 acres in area and not included in any other village or any other city or borough, said tract being described as follows, to-wit: South Half of Southeast Quarter (S $\frac{1}{2}$  of SE $\frac{1}{4}$ ) of Section Nineteen (19) and the Northwest Quarter of Northeast Quarter (NW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section Thirty (30), all in Township One hundred forty (140), Range Thirty (30), Cass County, Minnesota, be and the same be hereby annexed to, included within, and made a part of the incorporated Village of Hackensack, Minnesota.
