CHAPTER NO. 332

AN ORDINANCE EXTENDING THE COMPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CENTAIN UNINCORPORATED TERPITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMIUS AND ABUTTING THEREON.

WHEREAS, certain territory described below, is not presently included within the corporate limits of any incorporated city, village or borough, and

HERLAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City of Montevideo and is deemed to be urban in character,

NOW THEREFORE, the City of Montevideo does ordain:

Section 1. Territory Annexed. The corporate limits of the City of Montevideo, Minnesota are hereby extended to include platted and unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

> A parcel of land in the Southwest Quarter of the Southwest Quarter of Section 8, Township 117 North, Range 40 West, particularly described as follows: Beginning at the southeast corner of Lot 4, Block 3, Kohr's Brockside Addition to Montevideo; thence East along the North line of Washington Avenue 210 feet; thence North at right angles to Washington Avenue 257 feet, more or less, to the North line of said Southwest Quarter of the Southwest Quarter; thence West along the said North line of the Southwest Quarter of the Southwest Quarter 279 feet, more or less, to the Northeast corner of Outlot Two in said Bouthwest Quarter of the Bouthwest Quarter; thence South along the East line of said Outlot 2, 137 feet; thence East along the North line of Lot 4, Block 3, Kohr's Brookside Addition to Montevideo 34.6 feet to the Northeast corner of said Lot 4, Block 3; thence Southeasterly along the East line of said Lot 4, Block 3, to the point of beginning, containing 1.52 acres.

Parcel 2. The South seventy (70) feet of the East Half of Lot Eleven (11) in Block Two (2) of Ira B. Wolfe Second Subdivision in the Southeast Quarter of the Southeast Quarter of Section 6, Township 117, Range 40, Chippewa County, Minnesota.
