CHAPTER NO. 332

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below, is not presently included within the corporate limits of any incorporated city, village or borough, and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City of Montevideo and is deemed to be urban in character,

NOW THEREFORE, the City of Montevideo does ordain:

Section 1. Territory Annexed. The corporate limits of the City of Montevideo, Minnesota are hereby extended to include platted and unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Parcel 1. A parcel of land in the Southwest Quarter of the Southwest Quarter of Section 8, Township 117 North, Range 40 West, particularly described as follows: Beginning at the southeast corner of Lot 4, Block 3, Kohr's Brookside Addition to Montevideo; thence East along the North line of Washington Avenue 210 feet; thence North at right angles to Washington Avenue 257 feet, more or less, to the North line of said Southwest Quarter of the Southwest Quarter; thence West along the said North line of the Southwest Quarter of the Southwest Quarter 279 feet, more or less, to the Northeast corner of Outlet Two in said Southwest Quarter of the Southwest Quarter; thence South along the East line of said Outlet 2, 137 feet; thence East along the North line of Lot 4, Block 3, Kohr's Brookside Addition to Montevideo 34.6 feet to the Northeast corner of said Lot 4, Block 3; thence Southeasterly along the East line of said Lot 4, Block 3, to the point of beginning, containing 1.52 acres.

Parcel 2. The South seventy (70) feet of the East Half of Lot Eleven (11) in Block Two (2) of Ira B. Wolfe Second Subdivision in the Southeast Quarter of the Southeast Quarter of Section 6, Township 117, Range 40, Chippewa County, Minnesota.

Parcel 3. A tract of land described as follows: Beginning at the northwest corner of Lot 11 in Block 2 of Ira B. Wolfe Second Subdivision in the Southeast Quarter of the Southeast Quarter of Section 6, Township 117, Range 40, Chippewa County, Minnesota; running thence South along the west line of said Lot 11, 54.8 feet; thence East parallel to the South line of said Lot 11, 137 feet; thence North parallel to the

West line of said Lot 11, 54.8 feet to the North line of said Lot 11; thence West along the North line of said Lot 11 to the point of beginning.

Section 2. Filing. The City Clerk is directed to file a certified copy of this Ordinance with the Secretary of State, the County Auditor of Chippewa County, Minnesota, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This Ordinance shall take effect upon its passage and publication, as by the Charter provided, and the filing of certified copies as directed in Section 2. hereof.


