

ORDINANCE NO. 410

AN ORDINANCE ANNEXING PROPERTY TO THE CITY
OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, all of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have their property annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed.

NOW, THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1. That the following described property lying and being in the County of Ramsey, State of Minnesota, described as follows, to-wit:

(Except Trunk Highway 96) Lots one (1) through twenty four (24), Block eight (8) (Except Trunk Highway 96) Lots one (1) through thirteen (13), and Lots nineteen (19) through thirty two (32), Block nine (9), and all of Lots one (1) through nine (9), and part northerly of Highway 96 of Lots ten (10) and eleven (11), Block ten (10), all in Cobb's rearrangement of Cobb's Out Lots, White Bear, Minnesota, according to the recorded plat thereof on file and of record in the office of the Register of Deeds in and for said County.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota, and the said property is hereby declared to be an addition to said City.

Section 2. That upon the effective date of this Ordinance such property shall become a part of said City as effectively and as if it has been originally a part thereof.

Section 3. That this Ordinance shall take effect and be in force from and after its passage and publication, and the City Manager of the City of White Bear Lake, Minnesota, is directed to file and record a certified copy of this Ordinance in the office of the County Auditor, Ramsey County, Minnesota, the office of the Secretary of State for the State of Minnesota, and the Minnesota Municipal Commission.
