I hereby make application for retirement as Judge of the District Court, Seventh Judicial District, pursuant to the pertinent provisions of MS490.101-102, such retirement to become effective June 19th, 1965.


I was born June 21st, 1891, and was 73 years of age on June 21st, 1964. I have served continuously as district judge since December 5th, 1935, and was serving as a district judge at the time of the enactment of Laws of 1949, Chapter 640, April 23rd, 1949, coded as MS490.101-102.

My first wife, Blanche O. Wilson, died April 4th, 1960, at Minneapolis while I was then serving there on assignment, and on June 6th, 1962, I married Lillian Walfred, the widow of Dr. Karl A. Walfred of St. Cloud, her maiden name having been Lillian Johnson, and our present home address is 2804 Rivershore Drive, Moorhead, Minnesota. She was born June 14th, 1901.

I hereby waive my right to any salary as District Judge subsequent to June 19th, 1965, the effective date of my retirement. Thereafter I am to receive the retirement pay provided by statute.

I enclose herewith copy of Affidavit of Retirement, the original of which I am forwarding for filing to the Hon. Joseph L. Donovan, Secretary of State, St. Paul, Minnesota.
