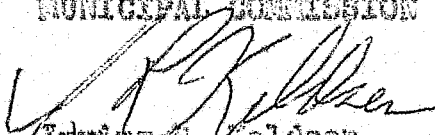

ORDINANCE NO 59

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ISANTI, ISANTI COUNTY, MINNESOTA, TO INCLUDE CERTAIN TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE ISANTI VILLAGE LIMITS.

THE VILLAGE COUNCIL OF ISANTI DO ORDAIN AS FOLLOWS:

Section 1. Declaration. It is hereby determined that the territory described below is completely surrounded by land within the municipal limits of the Village of Isanti, and is so conditioned as to properly be subjected to village government, and that the annexation thereof would be to the best interests of the Village of Isanti and the territory affected.

Section 2. Territory Annexed. The corporate limits of the Village of Isanti are hereby extended to include the territory described as follows, to-wit:

Commencing at the Northwest corner of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section 29, Township 35, Range 23, thence 235 feet Easterly on the North line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$; thence Southerly 185 feet 3 $\frac{11}{16}$ inches parallel to West line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$; thence 235 feet Easterly to West line and parallel to North line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$; thence 185 feet and 3 $\frac{11}{16}$ inches Northerly on West line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$ to point of commencement, said piece of land containing 1 acre, more or less.

Also, including that portion of the public street abutting the north side of the above described property, more particularly described as follows, to-wit: Commencing at the Northwest corner of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Twenty-nine (29), Township Thirty-five (35), Range Twenty-three (23), thence 235 feet easterly on the North line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$; thence North 33 feet; thence West parallel to first course, 235 feet to the West line of the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$) of said Section 29; thence South on said West line, 33 feet to the point of commencement.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Secretary of State, the Minnesota Municipal Commission, and the Isanti County Auditor, all pursuant to Minnesota Statutes Sec. 414.03, as amended.
