

ORDINANCE NO. 385

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF OWATONNA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND ENTIRELY SURROUNDED BY LAND WITHIN THE MUNICIPAL LIMITS.

WHEREAS, the City Council of the City of Owatonna has been advised that the territory hereinafter described is entirely and completely surrounded by land within the municipal limits of said City of Owatonna; and

WHEREAS, the quantity of land embraced within the area described hereinafter and bounded as described is .41 acres more or less of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the owners of the said property hereinafter described, Eugene E. Carrel and Bessie A. Carrel, husband and wife, desire that said property be annexed to the City of Owatonna and no objection to said annexation having been received from the Town Board, the County Board or the governing body of any municipality, whose boundaries abut upon the boundaries of the land to be annexed.

The City Council of the City of Owatonna, Minnesota, do ordain:

Section 1. The City Council hereby determines:

(1) that the annexation will be to the best interests of the city and of the territory affected.

(2) that the property described herein is completely surrounded by land within the municipal limits of the City of Owatonna, and is, or is about to become urban or suburban in character; and

(3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it has originally been a part thereof;

Commencing at the Northwest Corner of the East 10 acres of the Northwest Quarter of the Northeast Quarter of Section 21, Township 107 North, Range 20 West, thence East 60 feet, thence South 297 feet, thence West 60 feet, thence North 297 feet to point of beginning.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
