ORDINANCE NO. 270

BEING AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE CITY OF ORTONVILLE, MINNESOTA,
TO INCLUDE CERTAIN PROPERTY OWNED BY THE ZION
EVANGELICAL LUTHERAN CHURCH OF ORTONVILLE, MINN.

The City Council of the City of Ortonville, Minnesota,
does ordain:

Section 1. Territory Annexed. Petition having been
duly filed with the City Council of the City of Orton-
ville, Minnesota by Rev. Ralph D. Darggson, President
and Erwin L. Olson, Secretary for the Zion Evangelical
Lutheran Church, owner of a certain tract of land
abutting on the corporate limits of the said City, as
herein described, the corporate limits of the City of
Ortonville, Minnesota, are hereby extended to include
that certain tract of land, described as follows:

Lots A & B of the Northwest Quarter of
the Southwest Quarter (NW 1/4 SW 1/4) of
Section Four (4), Township One Hundred
Twenty-one North (121N), Range Forty-
six West (46W), Big Stone County,
Minnesota

Section 2. Effective Date. This ordinance shall take
effect thirty (30) days after its publication.
