

ORDINANCE NO. 1300

AN ORDINANCE ANNEXING TO THE CITY OF ROCHESTER, MINNESOTA, CERTAIN PLATTED LANDS IN ALLENDALE--A SUBDIVISION OF THE SOUTHWEST QUARTER OF SECTION TWENTY-TWO, TOWNSHIP ONE HUNDRED SEVEN NORTH, RANGE FOURTEEN WEST, OLMSTED COUNTY, MINNESOTA.

The Common Council of the City of Rochester do ordain:

Section 1. The City of Rochester, Minnesota, is the owner of the lands described herein, which lands abut upon the present territorial limits of the City of Rochester. The said lands owned by the City are located in Cascade Township, Olmsted County, Minnesota, and are described as follows:

Lot One (1) less the east 250 feet,

Lot Two (2) less the east 250 feet,

Lot Three (3) less the east 150 feet of the south 170 feet, and including that portion of 18th Avenue Northwest abutting the north 30 feet of said Lot Three (3),

Lot Four (4) less the east 200 feet, all in Allendale--a Subdivision of the Southwest Quarter of Section 22, Township 107 North, Range 14 West, Olmsted County, Minnesota.

Section 2. The Common Council of the City of Rochester hereby determines that the lands described in Section 1 abut upon the present territorial limits of the City of Rochester, are so conditioned as to be properly subjected to Municipal Government, and the annexation of said lands will be in the best interests of the City of Rochester and the lands affected.

Section 3. Therefore, the lands described in Section 1 above are hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if they had originally been a part thereof.

Section 4. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.
