ORDINANCE NO. 415

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF  
WHITE BEAR LAKE, MINNESOTA

WHEREAS, a majority of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, the City Council has held a public hearing as required by the laws of the State of Minnesota, and

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed.

NOW THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1 That the following described real estate situated in Ramsey County, Minnesota:

(1) Lots 1 to 14 inclusive, Block 1 and Lots 1 to 14 inclusive, Block 2, all in Interlachen Gardens, according to the recorded plat thereof, together with the public street known as Garden Lane included in said plat of said Interlachen Gardens;

(2) Lots 2 and 3, and that part of Lot 9 north of extended north line of Lot 8 and West 16.5 feet of Lot 9 of the part south of said extended line, all in Auditor's Subdivision No. 49;

(3) Lot 8 of the Subdivision of Southwest Quarter of Southwest Quarter of Section 11, Township 30 and Range 22 according to Plat recorded in 27 of Miscellaneous page 180; and

(4) Lot 8 of Auditor's Subdivision No. 49 except the South 120.60 feet thereof

Excepting therefrom any real estate which is already within the City of White Bear Lake.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota, and the said property is hereby declared to be an addition to said City.

Section 2 Upon the effective date of this Ordinance such property shall become a part of said City as effectively and as if it has been originally a part thereof.

Section 9 This Ordinance shall take effect and be in force from and after its passage and publication, and the City Manager of the City of White Bear Lake, Minnesota, is directed to cause a certified copy of this Ordinance to be recorded and filed in the office of the County Auditor, Ramsey County, Minnesota, and the office of the Secretary of State for the State of Minnesota, and the Minnesota Municipal Commission.

Passed by the Council this 23rd day of March, 1965.




