

ORDINANCE NO. 418

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, all of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed.

NOW THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1 That the following described real estate situated in Ramsey County, Minnesota:

West 693 feet of Government Lot 1, Section 16, Town 30, Range 23 lying North of (Wagon Road) Birch Lake Blvd. North.

Remainder of Government Lot 1, Section 15, Town 30, Range 22 North of (Blvd.). Except property described in Documents 1520430 and 1574020.

West 1/2 Government Lot 2, Section 15, Town 30, Range 22 lying North of Birch Lake Blvd. North and 1/4 Section Line; Except the East 300 feet of West 360 feet lying South of the North 902.24, and North of Birch Lake Blvd. North, also except property described in documents 1520430 and 1574020.


