

ORDINANCE NO. 420

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF
WHITE BEAR LAKE, MINNESOTA

WHEREAS, all of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed.

NOW THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1 That the following described real estate situated in Ramsey County, Minnesota:

Subject to widened State Highway 96/96 and Birch Lake Blvd. beginning on North line of and 1210 5/10 feet East from Northwest corner of Northwest 1/4 then East 685 5/10 feet, then South 1760 feet then West 277 5/10 feet then North 33 degrees 30 minutes West 627 5/10 feet then North 1267 5/10 feet to point of beginning; part of Section 22, Town 30, Range 22

be and the same is hereby annexed to the City of White Bear Lake, Minnesota, and the said property is hereby declared to be an addition to said City.

Section 2 Upon the effective date of this Ordinance such property shall become a part of said City as effectively and as if it has been originally a part thereof.

Section 3 This Ordinance shall take effect and be in force from and after its passage and publication, and the City Manager of the City of White Bear Lake, Minnesota, is directed to cause a certified copy of this Ordinance to be recorded and filed in the office of the County Auditor, Ramsey County, Minnesota, the office of the Secretary of State for the State of Minnesota, and the Minnesota Municipal Commission.
