FROM THE CITY OF FAIRMONT, MARTIN COUNTY, MINNESOTA, PUR-  
SUANT TO MINN STAT CHAP 414.06

ORDER

A petition has been filed on the 23rd day of April, 1965, by the City of Fairmont, Martin County, State of Minnesota, and all of the owners of the property described herein for the detachment of said land from the City of Fairmont.

The affected property is adjacent to the city boundaries of Fairmont. The land is unplatted and occupied and used exclusively for agricultural purposes. The land is not needed for reasonable anticipated future development.

The petition is in the proper legal form and sets forth the information required in Minn. Stat. Chap 414.06, and upon all the files and records, the Minnesota Municipal Commission being fully advised in the premises,

IT IS ORDERED: That the following described property be, and the same hereby is, detached from the City of Fairmont, Martin County, State of Minnesota, and made a part of Fairmont Township, Martin County, Minn:

Commencing at the NE Corner of Sec 3, thence S to Chicago, Northwestern Railroad thence W to E 1/16 line, thence N to the center of the SE $\frac{1}{4}$ , Sec 3, thence W to the center of SW $\frac{1}{4}$  Sec 3 thence S to the Chicago, Northwestern Railroad right-of-way thence W along said Chicago, Northwestern right-of-way to the E 1/16 line of Sec 4, thence N along said E 1/16 line of Sec 4 to the Chicago, Milwaukee, St. Paul and Pacific right-of-way, thence NE along said Chicago, Milwaukee, St. Paul and Pacific right-of-way to the EW one  $\frac{1}{4}$  line of said Sec. 4, thence E on said EW $\frac{1}{4}$  line of Sections 4 and 3 140 rods more or less to the SW corner of the land owned by Gordon Swanson, thence N along boundary line of the land of said Gordon Swanson to the right-of-way of the Chicago, Milwaukee, St. Paul and Pacific Railway, thence Northeast along said right-of-way to the N line of Sec. 3, thence E along the N line of Sec 3 to the point of beginning, containing 477 $\frac{1}{2}$  acres more or less.
