An Ordinance annexing a part of Government Lot One (1), Section Twenty-nine (29), Township Thirty (30) North, Range Twenty-one (21) West, (being part of the North Five (5) acres of Block Twelve (12) of Lakeview (now vacated).

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of the land hereinafter described, in Washington County, Minnesota, containing less than two hundred acres, abutting on the Easterly side of the Village of Mahtomedi, requesting the annexation of said land to said Village, said Petition having been duly filed with the Clerk of said Village, and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtomedi are hereby extended to include said land described as follows:

Beginning at an iron monument set at the northeast corner of Block Twelve (12) of Lakeview (now vacated) and running west along the North line thereof two hundred (200) feet to an iron monument; thence south on a line parallel to the East line of said Block Twelve (12), a distance of three hundred ten (310) feet to a point; thence east on a line parallel to said North line of Block Twelve (12), a distance of two hundred thirty (230) feet to a point; thence north on a line parallel to the East line of said Block Twelve (12); a distance of three hundred ten (310) feet to a point; thence west, a distance of thirty (30) feet to the Northeast corner of Block Twelve (12), the place of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and with the Minnesota Municipal Commission and from and after its publication.
