ORDINANCE NO. 180 An Ordinance amexing a part of Government Lot One (1), Scotion Twenty-nine (29), Township Thirty (30) North, Range Twenty-one (21) West, (being part of the North Five (5) acres of Block Tuelve (12) of Lekeview (non vecated). THE VILLAGE COUNCIL OF THE VILLAND OF HANTONEDI DO ORDAIN AS FOLIANES: Section 1. That pursuant to that certain petition signed by all of the owners of the land hereinafter described, in Vashington County, Minnesota, containing loss than two hundred acres, abutting on the Easterly side of the Village of Mahtomedi, requesting the ennexation of soid land to said Village, seid Petition having been duly filed with the Clark of seid Villege, and it appearing that such amexation will be to the best interests of the Village and of the territory affected, the Village boundaries of the Village of Mahtemedi are hereby extended to include sold land described as follows: Beginning at an iron monument set at the northcast corner of Block Twelve (12) of Lakeview (now vecated) and running west along the North line thereof two hundred (200) feet to an iron monument; thence south on a line parallel to the East line of said Block Twelve (12), a dictance of three hundred ten (310) feet to a point; thence east on a line parallel to said North line of Block Twelve (12), a distance of two hundred thirty (230) feet to a point; thence north on a line parallel to the East line of said Block Twelve (12); a distance of three hundred ten (310) feet to a point; thence west, a distance of thirty (30) feet to the Northeest corner of Diock Tuelve (12), the place of beginning. and that said territory is hereby made a part of the Villege of Mahtemedi as effectually so if the same had originally been a part of said Villago.
