CHAPTER NO. 339

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO, MINNESOTA TO INCLUDE CERTAIN PLATTED LANDS.

THE CITY OF MONTEVIDEO DOES ORDAIN AS FOLLOWS:

SECTION I. A Petition having been filed with the governing body of the City of Montevideo, Minnesota, by the sole owner of the following described real estate to have such land included within the City of Montevideo, Minnesota:

> A platted parcel of land in the West Half (W 1/2) of Section Seventeen (17), Township One Hundred Seventeen (117), Range Forty (40), Chippewa County, Minnesota, known, designated and platted as Lennard E. Brown' Addition.

SECTION II. The quantity of land embraced within the foregoing description, is less than 100 acres. 43.5 below, make or lend

SECTION III. The City Council hereby determines that the annexation will be to the best interest of the City of Montevideo, Minnesota and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.
