AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITCHFIELD, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated 12-7-64, requesting annexation of the territory hereinafter described was duly presented to the council on the 18th day of January 1965; and
