## ORDINANCE NO. 198

AN ORINANCE EXTENDING THE

CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLAT. TED LAND IN THE WEST HALF OF SECTION 36, TOWNSHIP 152, NORTH OF RANGE 50, WEST OF THE FIFTH PRINCIPAL MERID. IAN, POLK COUNTY, MINNES-OTA, NOT EXCEEDING TWO

HUNDRED ACRES, WHICH TRACT CONTAINS 42.133 ACRES The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by Homer L. Matheson and Margaret M. Matheson, Vernon G. Hagen and Marilyn Hagen, Thomas W. Ryan and Joan Ryan, Gerald C. Ryan and Suzanne Ryan, S. K. Company, Inc., and City of East Grand Forks, being all of the owners of the land hereinafter described, to have such land included within the City limits of the City of East Grand Forks, Minnesota; that copies of said petition were filed with the Minnesota Municipal Commission, the Town Board of Grand Forks Township and the County Board of Polk County, Minnesota; that more than 30 days have elapsed since such filings of said petitions and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:

A tract of land in Section Thirty-A tract of land in Section Thirty-six (36), Township One Hundred Fifty-two (152) North, Range Fifty (50), West of the Fifth Principal Meridian, which tract is described as follows, to-wit: Commencing at the Southwest corner of Section 36, Township 152 North, Range 50 West of the 5th Principal Meridian and then-5th Principal Meridian and thence proceeding northerly along the West line of said Section 36 for a distance of 1324.85 feet to the quarter-quarter line running east and west through the South Half of said Section 36; thence deflecting right and proceeding easterly, along said east-west quarter-quarter line for a dis-tance of 397.63 feet to a point of intersection with a line lying parallel to and 397.68 feet distant easterly from the West line of said Section 36 which point of intersection is the true point of beginning; thence deflecting left and proceeding northerly along said line lying parallel to and 397.68 feet distant easterly from the West line of Section 36 for a distance of 1364.77 feet to a point lying 40.00 feet distant northerly from the east-west quarter section line in the said Section 36; thence deflecting right and proceeding easterly along a line lying parallel to and 40.00 feet distant northerly from the east-west quarter section line for a distance of 30.44 feet to a

point lying 428.12 feet distant easterly from the West line of said Section 36; thence deflecting left and proceeding northerly along a line lying parallel to and 428.12 feet distant easterly from the West line of Section 36 for a distance of 687.06 feet to a

point lying 727.06 feet distant northerly from the east-west quarter section line in the said Section 36; thence deflecting right and proceeding easterly on a line lying parallel to and 727.06 feet distance northerly from the east-west quarter section line in Section 36 for a distance of 765.00 feet to a point lying 1193.12 feet distant easterly from the West line of the said Section 36; thence deflecting right and proceeding southerly on a line lying parallel to and 1193.12 feet distant eastto and 1193.12 feet distant east-erly from the said West line of Section 36 for a distance of 767.06 feet to a point lying 40.00 feet distant southerly from the east-west quarter section line in the said Section 36; thence deflecting right and proceeding westerly on a line lying parallel to and 40.00 feet distant south-erly from the said east-west quarter section line for a dis-tance of 565 44 foot to a paint tance of 565.44 feet to a point lying 627.68 feet distant easterly from the West line of the said Section 36; thence deflecting left and proceeding southerly on a line lying parallel to and 627.68 feet distant easterly from the West line of the said Section 36 for a distance of 1080.73 feet more or less to a point lying 204.00 feet distant northerly from the aforesaid quarter-quarter section line running east and west through the South Half of Section 36; thence deflecting left and proceeding easterly on a line lying parallel to and 204,00 feet distant northerly from the said quarter-quarter section line running east and west through the South Half of Section 36 for a distance of 4659.64 feet to the East line of the said Section 36; thence deflecting right and proceeding southerly along said East line of Section 36 for a dis-tance of 204.00 feet to the said quarter-quarter section line running east and west through the South Half of Section 36; thence deflecting right and proceeding westerly along said quarter-quarter section line for a dis-tance of 4890.04 feet to the true point of beginning with said described tract comprised of 42.133 acres lying wholly within Section 36; Township 152 North, Range 50 West of the 5th Principal Mer-

idian, County of Polk, State of Minnesota. Section 3. That the quantity of

said land herein described is 42.133 acres.

Section 4. That the City Council hereby determines (1) That the quantity of land embraced within the foregoing description is less than 200 acres; (2) that the annex-ation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected; (3) that the territory and land described as above abuts upon the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government and is urban in character; (4) that the petition for annexation was signed by all of the owners of the land and real estate hereinabove described, except a minor part thereof owned by the State of Minnesota for Trunk Highway purposes and shown on the plat attached to the petition as part of U.S.T.H. No. 2.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2., and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the County Auditor and the Secretary of State of the State of Minnesota.

Section 7. This ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6. and be given the number 198.
