ORDINANCE NO. 377

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, PRINCESOTA, TO INCLUDE GERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington Do Ordein:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such property included within the City of Worthington, Minnesota:

That part of the Southeast Quarter (SE2) of Section 15, Township 102 North, Range 10 West of the 5th P.M., Nobles County, Minnesota, described as follows:

Commencing at the northwest corner of Homewood Hills First Addition, which point is the point of beginning; thence north 90 degrees 00 minutes east (assumed bearing) and along the north line of Homewood Hills First Addition for 777.5 feet; thence north 45 degrees 03 minutes east and along the northwesterly side of Homewood Hills First Addition for 107.78 feet; thence north 45 degrees 03 minutes west for 1200.94 feet; thence south 0 degrees 13 minutes west for 925.00 feet to the true point of beginning, subject to highway essements now in effect.

Section 2. The quantity of land embraced within the foregoing description and bounded and described is 7.4 acres.

Section 3.
