
SUBJECT: CLEARBROOK ANNEXATION A-692

VILLAGE ORDINANCE ANNEXING LAND

The Village Council of the Village of Clearbrook does hereby ordain as follows:

Section 1. The following described land, abutting the municipality of Clearbrook, Minnesota, is hereby annexed to and made a part of the incorporated territory of the Village of Clearbrook, Minnesota, to-wit:

A tract of land Two Hundred Seventy-eight and six-tenths (278.6) Feet by One Hundred Forty (140) Feet, lying and being in the southeast quarter of the southeast quarter (SE 1/4), Section Thirty (30), Township One Hundred Forty-nine (149) North, Range Thirty-seven (37) West, of the fifth principal Meridian, according to the government survey thereof, and more particularly described as follows, to-wit:

Commencing at the southeast corner of Sakre's Third addition to the Village of Clearbrook; thence West on the South boundary line of Fourth Avenue, a distance of Two Hundred Seventy-eight and six-tenths (278.6) Feet, thence South at an angle of 90° for a distance of One Hundred Forty (140) Feet, thence East parallel with the South boundary line of Fourth Avenue for a distance of Two Hundred Seventy-eight and six-tenths (278.6) Feet, thence North at an angle of 90°, a distance of One Hundred Forty (140) Feet, to the point of beginning.

Section 2. The Village Council of the Village of Clearbrook hereby determines that the annexation of the above described tract of land will be to the best interest of the municipality of Clearbrook, Minnesota, and of the above described territory and that this annexation is made pursuant to M.S.A. Section 414.03, subd. 2.

Section 3. This ordinance shall take effect and be in force from and after its publication.
