

ORDINANCE NO. 1008

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO THE EAST.

WHEREAS, RICHARD E. GARMER is the Owner of the land hereinafter described,

AND WHEREAS, said Owner above mentioned has Petitioned the Common Council of Austin, Minnesota to have the hereinafter described premises annexed to the corporate limits of the City of Austin, Minnesota,

AND WHEREAS, said premises adjoin the City of Austin and are subject to incorporation within the corporate limits of the City of Austin, Minnesota, and by Petitioning to the governing body of Austin, Minnesota,

AND WHEREAS, said premises are hereinafter described are about to become urban in character and municipal government of the area hereinafter described is required in order to protect the public health, safety and welfare of said territory, and regulate construction therein which may be reasonably expected to occur within a reasonable time, and annexation of the premises hereinafter described is with the best interest of the City of Austin and the territory to be annexed,

AND WHEREAS, said premises are well fitted to be under municipal government and are well adapted for municipal use,

AND WHEREAS, the premises hereinafter described desired to be annexed are less than 200 acres and the Petition for Annexation has been signed by the Owners of the property and copies of said Petition have been duly filed with the Municipal Commission, the County Board, and the Town Board of the land as required by law, and that more than thirty days has expired since the same were filed.

NOW THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN, MINNESOTA, DO ORDAIN:

SECTION 1. The land hereinafter described is to be added to and incorporated within the corporate limits of the City of Austin, Minnesota, and said Common Council does hereby declare said premises hereinafter described to be incorporated within and to be a part of the City of Austin, Minnesota. The premises are to be described as follows:

All that part of the Northwest Quarter of the Southeast Quarter of Section 1, Township 102, Range 18, lying North of the center line of Winona Street in an land addition to the City of Austin, Minnesota, extended East and lying

West of the West line of the Austin Municipal Airport property, and excepting the West 200 feet heretofore taken by the State of Minnesota for highway purposes. The North line of the property is approximately 971 feet and the South line is approximately 1019 feet and the acreage is approximately 7.75 acres.

SECTION 2. The above described land extending the corporate limits of the City of Austin shall be added to the end of Chapter 2300, Austin Compilation in the regular chronological order.

SECTION 3. Copies of this Ordinance shall be filed with the Municipal Commission, the County Auditor, of Mower County, Minnesota, and with the Secretary of State of Minnesota.
