EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO THE NORTH.

WHEREAS, the City of Austin is the sole owner of the land hereinafter described and,

WHEREAS, said premises abjoin the City of Austin and are subject to incorporation within the corporate limits of Austin,

AND WHEREAS, said premises hereinafter described are about to become urban in character and municipal government of the area hereinafter described is required in order to protect the public health, safety, and welfare of said territory, and annexation of the premises hereinafter described is for the best interest of the City of Austin and the territory to be annexed, and said premises are well suited to be under municipal government and are well adapted for municipal use.

NOW THEREFORE THE COMMON COUNCIL OF THE CITY OF AUSTIN, MINNESOTA DO ORDAIN:

SECTION 1. The land hereinafter described is to be added to, and incorporated within the corporate limits of the City of Austin, Minnesota, and said Common Council does hereby declare said premises hereinafter described to be urban in character and to be incorporated within and to be a part of the City of Austin, Minnesota. The premises are described as follows:

Commencing at the southeast corner of the northeast quarter of the southeast quarter of Section 33, Township 101 north, Range 10 west; thence westerly along the south 1/4 line of said section, a distance of 320.75 feet; thence northerly a distance of 987.5 feet to the intersection of the south right of way line of S. T. R. no. 252; thence easterly along said south right of way line a distance of 320.75 feet to the intersection of the east section line of Section 33; thence north along said section line a distance of 987.5 feet to the point of beginning. The above described land contains 7.9 acres.

SECTION 2. The above described land extending the corporate limits of the City of Austin, Minnesota shall be added at the end of Chapter 2304, Austin Compilation in regular chronological order.
