AND WHEREAS, the Petition was signed by all the owners,

AND WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed,

AND WHERDAS, the land described in the Petition abute the City of Austin on the western boundary thereof,
