ORDINANCE NO. 1038

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO THE EAST.

WHEREAS, the City of Austin is the owner of the land hereinafter described,

AND WHEREAS, said premises adjoin the City of Austin and are subject to incorporation within the corporate limits of Austin,

AND WHEREAS, said premises hereinafter described are about to become urban in character and municipal government of the area hereinafter described is required in order to protect the public health, safety, and welfare of said territory, and annexation of the premises hereinafter described is for the best interest of the City of Austin and the territory to be annexed, and said premises are well suited to be under municipal government and are well adapted for municipal use.

NOW THEREFORE THE COMMON COUNCIL OF THE CITY OF AUSTIN, MINNESOTA, DO ORDAIN:

SECTION 1. The land hereinafter described is to be added to, and incorporated within the corporate limits of the City of Austin, Minnesota, and said Common Council does hereby declare said premises hereinafter described to be urban in character and to be incorporated within and to be a part of the City of Austin, Minnesota. The premises are described as follows:

Beginning at the Southwest corner of the Southwest one quarter of Section 31, Township 103 North, Range 17 West; thence North along the west line of said one quarter section a distance of 1,150 ft.; thence easterly at a deflection angle to the right of 90°00' a distance of 1,050 ft.; thence southerly at a deflection angle to the right of 90°00', to the south line of said one quarter section; thence westerly along the south line of said one quarter section to the point of beginning.

SECTION 2. The above described land extending the corporate limits of the City of Austin, Minnesota shall be added at the end of Chapter 2300, Austin Compilation in regular chronological order.

SECTION 3. Copies of this Ordinance shall be filed with the Municipal Commission, County Auditor of Howard County, Minn., and with the Secretary of State of Minnesota.
