ORDINANCE NO. 388

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF OWATONNA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND LESS THAN 200 ACRES IN AREA OWNED BY THE CITY OF OWATONNA

WHEREAS, Pursuant to the Provisions of Chapter 216, Laws of Minnesota 1965, The City of Owatonna has acquired the right to acquire the title to the property hereinafter described, which said property abuts the West corporate limits of the City; and

WHEREAS, the quantity of land embraced within the area described hereinafter and bounded as described is 150 acres more or less of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the population of the City of Owatonna, according to the 1960 Federal census is 13,409; and

WHEREAS, the City of Owatonna is a City of the Third Class operating under a Home Rule Charter adopted pursuant to the provisions of the Constitution and laws of the State of Minnesota.

NOW THEREFORE, the City Council of the City of Owatonna DO ORDAIN:

Section 1. That the following described property, referred to in the preamble of this Ordinance, situated in Steele County, Minnesota, to-wit:

All that part of the North East Quarter (NE $\frac{1}{4}$) Section Eight (8), Township One Hundred Seven (107) North, Range Twenty (20) West, and the North West Quarter (NW $\frac{1}{4}$) Section Nine (9), Township One Hundred Seven (107) North, Range Twenty (20) West, Steele county, Minnesota, lying west of trunk highway 35 and south of trunk highway 14; except the Chicago and Northwestern Railroad right of way; containing 150 acres more or less

be and the same hereby is annexed to the City of Owatonna, and shall, upon the effective date of this ordinance, become a part of the City as effectively as if it had been originally a part thereof.

Section 2. That said property be and hereby is designated to be included within a M-2 Heavy Manufacturing District as provided under the provisions of the Zoning Ordinance No. 326 of the City, and shall hereafter be subject to such zoning regulations as now, or may hereafter be provided by law.

Section 3. This Ordinance is enacted pursuant to the provisions of Minnesota Statutes, Chapter 414 and Section 414.03, thereunto enabling.

Section 4. Upon its adoption, approval and publication, a certified copy of this Ordinance together with a map showing the property annexed thereto shall be filed with each of the following:




Section 5. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 4.


