AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF PAIRFAX TO INCLUDE CEREALS UNFLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, the quantity of land ombraced within the cree deccribed in the Potition and bounded so described in three acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and,

WHEREAS, the Formen was signed by all evers of said lands.

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundries abut upon the boundries of the lands to be annexed; and,
