

AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF
WHITE BEAR LAKE, MINNESOTA

WHEREAS, a majority of the property owners of the real estate hereinafter described, have petitioned the City Council of the City of White Bear Lake, Minnesota, to have the following described real estate annexed to the City of White Bear Lake, Minnesota; and

WHEREAS, the City Council has held a public hearing as required by the laws of the State of Minnesota, and

WHEREAS, the City Council deems it advisable and in the public interest that said property be so annexed.

NOW THEREFORE, the City Council of the City of White Bear Lake, Minnesota, does ordain as follows:

Section 1 That the following described real estate situated in Ramsey County, Minnesota:

That part of Section 24, Township 30, Range 22 described as follows, to-wit:

Beginning at the intersection of the south boundary of property known as Arbor Drive (abandoned) and the center line of Myrie Avenue, proceeding northward along the line of the present White Bear Lake City limits across South Shore Boulevard to the north boundary of South Shore Boulevard, then in a westerly direction along the north boundary of South Shore Boulevard the most south westerly corner of part of Government Lot 1, north of South Shore Boulevard and between two parallel lines distant respectively 120 feet and 190 feet east of and parallel with east line of Thome's Lakeridge Addition in Section 24 and north on westerly line to lake (White Bear Lake) and then northeasterly and easterly along the shore line of said lake to the northwest corner of the west 120 feet of east 280 feet of part of Government Lot 2, north of South Shore Boulevard, then south along said boundary to South Shore Boulevard, continuing in the same direction across South Shore Boulevard to the south boundary of South Shore Boulevard, then in a westerly direction along said south boundary to its point of junction with the east boundary of Maccallum (Oak) Street, then south along the eastern boundary of said street to the point of its junction with the north boundary of Arbor Drive (abandoned), continuing in the same direction across Arbor Drive (abandoned) to the south boundary of Arbor Drive (abandoned), then in a west and southerly direction along the south boundary of Arbor Drive (abandoned) to its junction with the center of Myrie Avenue (point of beginning).

be and the same is hereby annexed to the City of White Bear Lake, Minnesota, and the said property is hereby declared to be an addition to said City.

Section 2 Upon the effective date of this Ordinance such property shall become a part of said City as effectively and as if it has been originally a part thereof.

Section 3 This Ordinance shall take effect and be in force from and after its passage and publication, and the City Manager of the City of White Bear Lake, Minnesota, is directed to cause a certified copy of this Ordinance to be recorded and filed in the office of the County Auditor, Ramsey County, Minnesota, the office of the Secretary of State for the State of Minnesota, and the Minnesota Municipal Commission.
