

**AN ORDINANCE**

Relating to the annexation of certain land to the City of Minneapolis.

The City Council of the City of Minneapolis do ordain as follows:

Section 1. It is determined to be in the best interests of the City of Minneapolis and of the land affected hereby that the petition of the owner of the land described in Section 2 of this ordinance be granted, and said land annexed to the City of Minneapolis.

Section 2. Pursuant to the provisions of Minnesota Statutes, Section 414.05, Subd. 2, the following described lands, declared to be land hereby annexed to and made a part of the City of Minneapolis, Hennepin County, State of Minnesota:

All of the northerly 30 feet of the west 275 feet of Section 20, R. 23 N., E. 23 W. and all that part of the westerly 30 feet of Section 20, R. 23 N., E. 23 W. that lies northerly of the south line of East 54th Street as platted in the City of Minneapolis.
