ORDINANCE NO. 10-13

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ST. MARTIN TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LANDS NOT EXCEEDING 200ACRES IN AREA, ABUTTING UPON THE VILLAGE LIMITS.

EMEMEAS, a cortain potition requesting annexation of the territory hereinafter described was duly presented to the Council on the 21st day of May, 1965; and

WHEREAS, the quantity of land embraced within the area described in the potition and bounded as described is less than 200 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough, and

WHENEAS, the petition was signed by all of the owners of property within the territory hereinafter described, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board and the boundaries of no other municipality abut upon the boundaries of the land to be annexed; and

THEMEAS, the land described in the petition abuts upon the Village limits at the southerly boundary thereof;

The Council of the Village of St. Martin, Minnesota, ordains:

Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the Village and of the territory affected, (2) that the territory described herein abuts upon the Village limits and is urban or suburban in character; and (3) that none of said territor, is now included within the limits of any city, village, or borous:

Section 2. Territory are exed. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof;

The Northerly Five Hundred (500) feet of the Northeast quarter of the Northeast quarter (NE NW), and the Northerly Five Hundred (500) feet of the Northeast quarter of the Northeast quarter (NINE), and the Northeast quarter (NINE), and the Northeast quarter of the Northeast quarter lying westerly of the center line of State Aid Read No. 12, of Stearns County, Minnesota as the same is now located and constructed, all of said lands being in Section Two (2), Township One Hundred Twenty Three (123), North of Range Thirty two (32) West of Stearns County, Minnesota
