AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE CITY OF MONTEVIDEO, MINNESOTA TO INCLUDE
CERTAIN PLATTED LANDS.

THE CITY OF MONTEVIDEO DOES ORDAIN AS FOLLOWS:

SECTION I. Petitions having been filed with the governing body of the City of Montevideo, Minnesota by the sole owners in fee of the following described real estate to have such lands included within the corporate limits of the City of Montevideo, Minnesota:

Sublot Fifteen (15) in Ira B. Wolfe Subdivision in Sublots Seven (7) through Seventeen (17) in the Southeast Quarter of the Southeast Quarter (SE 1/4 of SE 1/4) of Section Six (6) in Township One Hundred Seventeen (117) Range Forty (40), Chippewa County, Minnesota, according to the duly recorded Plat thereof on file and of record in the office of the Register of Deeds in and for Chippewa County, Minnesota. The quantity of land embraced within the foregoing description is 0.83 acres.

Lot Five (5) in Block Four (4) in Ira B. Wolfe Second Subdivision in the Southeast Quarter of the Southeast Quarter (SE 1/4 of SE 1/4) of Section Six (6) in Township One Hundred Seventeen (117), Range Forty (40), in Chippewa County, Minnesota, according to the duly recorded plat thereof. The quantity of land embraced within the foregoing description is 0.43 acres.

Wolfe's First Subdivision into the Sublots in the Southeast Quarter of the Southeast Quarter (SE 1/4 of SE 1/4) of Section Six (6), Township One Hundred Seventeen (117), Range Forty (40) in Chippewa County, Minnesota according to the duly recorded Plat thereof on file and of record in the office of the Register of Deeds in and for Chippewa County, Minnesota. The quantity of land embraced within the foregoing description is 0.83 acres.

and notice of said Petitions for Annexation having been filed with the town board of the Town of Sparta, the County Commissioners of the County of Chippewa and the Municipal Commission of the State of Minnesota and no objection to such annexation having been received.

SECTION II. The City Council hereby determines that the annexation will be to the best interest of the City of Montevideo, Minnesota and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government and control.

SECTION III. Therefore, the City of Montevideo, Minnesota does hereby ordain and declare that the property hereinbefore described be, and the same is hereby annexed to and included in the City of Montevideo, Minnesota as effectually as if it had been originally a part thereof.

SECTION IV. This Ordinance shall be final and shall take effect upon and after its passage and publication as by the City Charter provided and upon the filing of a certified copy thereof with the Minnesota Municipal Commission, the County Auditor, the Register of Deeds of Chippewa County,


