ORDINANCE NO. 343

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO, MINNESOTA TO INCLUDE CERTAIN PLATTED LANDS.

WHEREAS, the City of Montevideo is the owner in fee of that certain tract of land in the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section Eight (8), Township One Hundred Seventeen (117), Range Forty (40), described as follows:

> Beginning at a point on the North line of Outlot Four (4) in said Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) that is One Hundred Forty-five (145) feet West from the East line of said Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4); thence continue West along the North line of said Outlot Four (4) a distance of Five Hundred (500) feet; thence Northeasterly on a line that is perpendicular to the center line of Trunk Highway No. 7 at Survey Station 190 plus 20, a distance of One Hundred Seventy (170) feet, more or less, to a point that is seventy-five (75) feet from the said center line of Trunk Highway No. 7; thence Southeasterly on a line that is seventy-five (75) feet Southerly from and parallel to the said center line of Trunk Highway No. 7 a distance of Four Hundred Eighty (480) feet to the point of beginning, containing 0.94 acres.

WHEREAS, said tract of land abuts upon the corporate limits of the City of Montevideo and is so conditioned as properly to be subject to City government and contains 0.94 acres.

NOW, THEREFORE, the City of Montevideo does ordain and declare:

SECTION I. That the tract of land hereinbefore described be and the same hereby is annexed to and included in the City of Montevideo, Minnesota as effectually as if it had been a part thereof.

SECTION II. This Ordinance shall be final and shall take effect upon and after its passage and publication as by the City Charter provided and upon the filing of a certified copy there of with the Minnesota Municipal Commission, the County Auditor, the Register of Deeds of Chippewa County, Minnesota and the Secretary of State of the State of Minnesota.
