

ORDINANCE NO. 379

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such land included within the City of Worthington, Minnesota:

Commencing at the southwest corner of the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirteen (13), Township One Hundred Two (102) North of Range Forty (40), West of the 5th P.M., Nobles County, Minnesota; thence east along said section line a distance of 463.8 feet which is the east line of Douglas Avenue; thence north along the east line of Douglas Avenue, a distance of 948 feet, to the point of beginning; thence north along the east line of Douglas Avenue, a distance of 70 feet; thence east and parallel to said south section line, a distance of 160.20 feet; thence south and parallel to the east line of Douglas Avenue, a distance of 70 feet; thence west and parallel to said south section line, a distance of 160.20 feet to the point of beginning.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is .25 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on August 19, 1965, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the city are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.

Section 6. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 7. This ordinance shall take effect upon its passage and publication and upon the filing of the certified copies as directed in Section 6.
