

ORDINANCE NO. 1310

An ordinance amending an ordinance entitled "An Ordinance Annexing to the City of Rochester, Minnesota, Certain Platted Lands in Allendale—a Subdivision of the Southwest Quarter of Section Twenty-Two, Township One Hundred Seven North, Range Fourteen West, Olmsted County, Minnesota."

The Common Council of the City of Rochester do ordain:

Section 1. That so much of Section 1 of an ordinance entitled "An Ordinance Annexing to the City of Rochester, Minnesota, Certain Platted Lands in Allendale—a Subdivision of the Southwest Quarter of Section Twenty-Two, Township One Hundred Seven North, Range Fourteen West, Olmsted County, Minnesota," the same being Ordinance No. 1300 which reads as follows:

"Lot One (1) less the east 250 feet" is hereby amended to read:

"Lot One (1) less the east 200 feet."

Section 2. The foregoing amendment is necessary to correct an error in the description of the property annexed to the City of Rochester.

Section 3. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.
