An ordinance amending an ordinance entitled "An Ordinance Annexing to the City of Rochester, Minnesofa, Certain Platted Lands in Allendal—a Subdivision of the Southwest Quarter of Section Twenty-Two, Township One Hundred Seven North, Range Fourleen West, Olmsted County, Minnesofa."

The Common Council of the City of Rochester do ordain;
Section 1, That so much of Section 1 of an ordinance entitled "An Ordinance Annexing to the City of Rochester, Minnesofa, Certain Platted Lands in Allendale—a Subdivision of the Southwest Quarter of Section Twenty-Two, Township One Hundred Seven North, Range Fourteen West, Olmsted County, Minnesofa," the same being Ordinance No. 1300 which reads as follows:
