

ORDINANCE NO. 349

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF WASECA, MINNESOTA, PURSUANT TO AUTHORITY OF SPECIAL ACT OF THE LEGISLATURE OF THE STATE OF MINNESOTA.

THE COMMON COUNCIL OF THE CITY OF WASECA DO ORDAIN:

Section 1: WHEREAS, the Legislature of the State of Minnesota passed an Act (not coded) being Chapter No. 11 of the Laws of the State of Minnesota, 1965, whereby the governing body of the City of Waseca may, by Ordinance, annex to the City all of the lands in the lake beds of Clear Lake and Loon Lake, which lakes are now partially within the corporate limits of the City and whereas said Special Act has been approved by the Common Council of the City of Waseca at its regular meeting on the 26th day of August, 1965.

Section 2: All of the land in the lake beds of Clear Lake and Loon Lake not now within the corporate limits of the City of Waseca, are hereby annexed to the City of Waseca, Minnesota.

Section 3: That a duly certified copy of this Ordinance shall be filed with the Minnesota Municipalities Commission; the Waseca County Auditor; the Secretary of the State of Minnesota; and that a certified copy of this Ordinance shall be filed and recorded in the Office of the Register of Deeds of Waseca, Minnesota.

Section 4: This Ordinance shall take effect and be in full force from and after its passage and publication in accordance with law.

Passed by the Common Council of the City of Waseca, Minnesota, this 23rd day of September, 1965.
