

ORDINANCE NO. 197

AN ORDINANCE EXAMINING THE CORPORATE LIMITS  
OF THE CITY OF STAPLES AND INCORPORATING  
ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

SECTION 1. A petition has been filed with the governing body of the City of Staples, Minnesota, by the sole owner of the following described real estate to have such land included within the City of Staples, Minnesota:

The south 300 feet of Block 7 of O'Connor's Addition to Staples.

SECTION 2. The quantity of land embraced within the foregoing description and bounded as described is less than 200 acres.

SECTION 3. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

SECTION 4. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described by and the same is hereby annexed to, and included in, the City of Staples, Minnesota as effectually as if it had originally been a part thereof and that the corporate limits of said City are hereby extended to include said property together with all public streets and alleys included herein and a part thereof.

SECTION 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State, and from and after its passage and publication.
