

ORDINANCE NO. 189

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF STAPLES AND INCORPORATING  
ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. A petition has been filed with the governing body of the City of Staples, Minnesota, by the sole owner of the following described real estate to have such land included within the City of Staples, Minnesota:

That part of the West Half of the Northwest Quarter ( $W\frac{1}{2}$  of  $NW\frac{1}{4}$ ) of Section One (1), Township One Hundred Thirty-three (133) North, of Range Thirty-three (33) West, Todd County, Minnesota described as follows: Beginning at a point on the west line of Third Street which is 1,723.75 feet North of the Northeast Corner of "Brannons Addition" to Staples, Minnesota; thence west 926.5 feet, more or less, to the west line of said Section One (1), thence North 02 Degrees 14 minutes West 689.27 feet along said westline to the south line of the Judicial Ditch #8; thence North 77 Degrees 57 Minutes East 877 feet along said south line of Judicial Ditch #8; thence north 87 Degrees 49 Minutes East 95.75 feet along said South line of Judicial Ditch #8 to the West line of Third Street; thence south 875.48 feet along said west line of Third Street to the place of Beginning and All of Block Thirteen (13) and Block Fourteen (14) and that part of Block Twelve (12) "O'Connor Addition" to Staples described as follows: Beginning at the southwest corner of said Block Twelve, thence north 188.47 feet along the west line of said Block Twelve (12) to the south line of Judicial Ditch #8; thence north 88 Degrees 56 Minutes East 291.05 feet along the south line of said Judicial Ditch #8 to the east line of said Block Twelve (12); thence south 193.94 feet along the said east line of Block Twelve (12); thence west 291 feet along the south line of said Block Twelve to the Place of Beginning. Including all streets, alleys and public thoroughfares.

Section 2. The quantity of land embraced within the foregoing description and bounded as described is less than 200 acres.

Section 3. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described by and the same is hereby annexed to, and included in, the City of Staples, Minnesota as effectually as if it had originally been a part thereof and that the corporate limits of said City are hereby extended to include said property together with all public streets and alleys included herein and a part thereof, such annexation made pursuant to provisions of Minnesota Statutes §14.03, Subdivision 2 and 3.
