

Ordinance No. 92

AN ORDINANCE PROVIDING FOR ANNEXATION OF TERRITORY
TO THE VILLAGE OF SPRING VALLEY, MINNESOTA

The Village Council of the Village of Spring Valley,
Minnesota do ordain as follows:

Whereas Ordinance # 89 described certain property and referred to the same as being in the Township of Fillmore when in fact the same is located in the Township of Spring Valley in Fillmore County, Minnesota, the following ordinance is made and adopted to amend Ordinance # 89.

Whereas, the Village of Spring Valley, Minnesota is the owner of that parcel of land being located and situated in the County of Fillmore, and State of Minnesota, described as follows, to-wit:

The West One Hundred Thirty Two feet of the South half of the Northeast Quarter of the Southeast Quarter of the Northeast Quarter of Section Twenty-eight, Township One Hundred Three North Range Thirteen West of the Fifth Principal Meridian,

which property is a part of the Township of Spring Valley in Fillmore County, Minnesota, and abuts onto the Village Limits of the Village of Spring Valley, Fillmore County, Minnesota;

And Whereas, it is and will be for the best interest of the said Village and of the territory affected if said described real estate is annexed to the Village of Spring Valley, Minnesota.

WHEREFORE, said described real estate is hereby annexed to the Village of Spring Valley, Minnesota and this Ordinance shall take effect and be enforced from and after its passage and official publication and filing as required by law.

Further, that this Ordinance is adopted pursuant to Minnesota Statutes 1961, Section 414.03, Subdivision 2, as amended.
