ORDINANCE NO. 1046

WITNESSED THE FORTY-THREE DAY OF THE MONTH OF AUGUST IN THE YEAR

MINNESOTA, THE OWNERS OF THE PROPERTY HEREINAFTER DESCRIBED
FILED A PetITION REQUESTING THE ANEXATION OF THE TERRITORY
HEREINAFTER DESCRIBED WHICH WAS DULY PRESENTED TO THE COUNCIL.

AND WHEREAS, THE QUANTITY OF LAND DESCRIBED WITHIN THE
COUNCIL DESCRIBED IN THE PETITION AND BOUNDED AS DESCRIBED IS
LESS THAN 200 ACRES OF PLOTTED LAND, NO PART OF WHICH IS
INCLUDED WITHIN THE LIMITS OF AN INCORPORATED CITY, VILLAGE,
OR BOROUGH,

AND WHEREAS, THE PETITION WAS SIGNED BY ALL THE OWNERS,

AND FURTHER, NO OBJECTIONS TO THE ANEXATION HAVE BEEN
RECEIVED FROM THE TOWN BOARD, THE COUNTY BOARD, OR THE
GOVERNING BODY OF ANY MUNICIPALITY WHOSE BOUNDARIES ABUT
UPON THE BOUNDARIES OF THE LAND TO BE ANEXED,

NOW, THEREFORE, THE COUNCIL COUNSEL OF THE CITY OF AUSTIN,
MINNESOTA, DO ORDEA,

SECTION 1. The City Council hereby determines that the
anexation shall be to the best interests of the city and of
the territory affected; and that the territory described
herein abuts the city limits and is urban or suburban in
character; and that none of said territory is now included
within the limits of any city, village or borough.

SECTION 2. The corporate limits of the City are hereby
extended to include the platted lands as follows, and the
same is hereby annexed to and included within the City as
effectually as if it had originally been a part thereof.

First, in the township of Austin
Lot 41, Southgate Addition, Hennepin County, Minnesota.

SECTION 3. The City Recorder is hereby directed to file
corresponding copies of this ordinance with the Minnesota Municipal
Commission, the Secretary of State and the County Auditor.

SECTION 4. This ordinance takes effect on its passage
and publishing and the filing of the certified copies as
directed in Section 3.
