## ORDINANCE NO. 1049

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO THE EAST.

WARRAG, the owners of the property hereinafter described has filed a Petition requesting the annexation of the territory hereinafter described which Petition has been duly presented to the Council.

AMD WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is less than 200 acres of unplatted land,

AND WHERIAS, no objections to the annexation has been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed.

AND WEEREAS, the land described in the Petition abute the City of Austin on the East boundary thereof:

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN, MINNESOTA, DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation of the hereinafter described property will be to the best interests of the City and of the territory affected; and that the territory described herein abute the City limits and is urban or suburban in character; and that none of said territory is now included within the limits of any city, village or borough.

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the platted lands as follows, and the same is hereby assexed to and included within the City as effectually as if it had originally been a part thereof:

The following described portion of the South half of the Southeast Guarter of Section 35, Township 103 North, Range 18 West, Mower County, Minnesota,

Beginning at the Northwest corner of the Southeast Quarter of the Southeast Quarter of said Section 35; thence East 781,00 feet along the North line of said quarter-quarter-section;

Thence South 303.30 feet at a deflection angle to the right of 89° 49' to the Northeast corner of the land conveyed to Holiday Inns of America by deed dated December 5, 1963, and recorded in Book 249 of Deeds, Page 352;

Thence West 443.50 feet at a deflection angle to the right of 89° 49° along the Morth line of said land conveyed to Holiday Inns of America, to the West end of said line, which point lies on the Mortheasterly line of the tract of land (hereinafter called the Pure Oil Tract) conveyed to Pure Oil Company by deed dated October 13, 1959, and recorded in Book 224 of Deeds, Page 29, at a point 263.65 feet Northwesterly from the most Easterly corner of said tract;

Thence Northwesterly 336.35 feet at a deflection angle to the right of 370 42', along the Northeasterly line of said Pure Dil Tract to the most Mortherly corner of said tract:

Thence Southwesterly 88.7 feet at a deflection angle of 900 00' left, to the East corner of the deed end of the state highway right-of-way;

Thence Morthwesterly 100 feet at approximately right angles, along the dead end of said state highway rightof-way, and crossing into the Southwest Quarter of the Southeast Quarter of said Section 35, to the North corner of said dead end;

Thence North to the North line of the last-named quarterquarter-section to the North line thereof, on a course parallel to the East line thereof;

Thence East along the Morth line of the last-named quarter-quarter section to the point of beginning."

SECTION 3. The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4. This Ordinance takes effect on its passage and publishing and the filing of the certified copies as directed in Section 3.
