
Dear Mr. Bottloff:

AN ORDINANCE PROVIDING FOR ANNEXATION OF TERRITORIES
TO THE VILLAGE OF SPRING VALLEY, MINNESOTA

The Village Council of the Village of Spring Valley, Minnesota,
do ordain as follows:

Whereas the following parcels of property are completely sur-
rounded by land within the Municipal Limits of the Village of Spring Valley,
County of Fillmore and State of Minnesota.

And whereas, it is and will be for the best interest of said
Village and for the territory affected if said described real estate is annexed
to the Village of Spring Valley, Minnesota and said property is located and
situated in the County of Fillmore, and State of Minnesota, described as follows,
to-wit:

The East 164.5 feet of the West half of the South
east Quarter of the Northeast Quarter of Section
Twenty-eight, Township One Hundred Three, North,
Range Thirteen West, excepting the North 660 feet
thereof;

ALSO

The West 164.5 feet of the East 329 feet of the
West half of the Southeast Quarter of the North-
east Quarter of Section Twenty-eight, Township
One Hundred Three North, Range Thirteen West, ex-
cepting the North 660 feet thereof;

ALSO

The South 220 feet of the East 130 feet of the
West one-half of the West one-half of the South
east Quarter of the Northeast Quarter of Section
Twenty-eight, Township One Hundred Three, North,
Range Thirteen West.

WHEREFORE, said described real estate is hereby annexed to the
Village of Spring Valley, Minnesota and this Ordinance shall take effect and
shall be enforced from and after its passage and official publication and filing
as required by law.

Further, that this Ordinance is adopted pursuant to Minnesota
