

ORDINANCE NO. 93

AN ORDINANCE ANNEXING CERTAIN  
ABUTTING PROPERTY TO THE VILLAGE  
OF GIBBON, SIBLEY COUNTY, MINNESOTA

THE VILLAGE COUNCIL OF THE VILLAGE OF GIBBON ORDAINS AS FOLLOWS:

-1-

That the two tracts of land more particularly described as follows: -

PARCEL A: The Southeast Quarter of the Southeast Quarter and all of that portion of the Southwest Quarter of the Southeast Quarter lying and being East of a line drawn due North and South parallel with, and 633 feet East of the West line of said Southwest Quarter of the Southeast Quarter, all in Section Number Two (2), in Township Number One Hundred Twelve (112) North, of Range Number Thirty-one (31) West. Excepting therefrom all that portion thereof included in Industrial Addition to the Village of Gibbon, Sibley County, Minnesota, according to the recorded Plat thereof.

PARCEL B: All of Industrial Addition to the Village of Gibbon, Sibley County, Minnesota, according to the recorded Plat thereof.

Both of which parcels of land are owned in fee title by the said Village of Gibbon, and both of which said parcels of land abutt upon and are adjacent to the said Village of Gibbon, be and the same hereby are annexed to the said Village and shall become a part of said Village as effectually as if said land had been originally a part thereof.

This ordinance shall be in full force and effect from and after its adoption and publication and the filing of certified copies with the governmental subdivisions as required by law.
