A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Lester Robert Haefner, and Mertyce M. Haefner, husband and wife, as sole owners of the following described real estate to have such land included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

Ι.
