The City of Mankato does ordain:

I.

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Leo J. Hoffman and Celestine A. Hoffman, husband and wife, as sole owners of the following described real estate to have such land included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

The South 150 feet of the SE<sup>1</sup>/<sub>4</sub> of the NW<sup>1</sup>/<sub>4</sub> of Section 16, Township 108, Range 26, containing 4<sup>1</sup>/<sub>2</sub> acres, more or less, according to the government survey.

II.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the east boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000 pursuant to the last census. That it appears from the records of the Clerk of the City of Mankato, Minnesota, that copies of the petition asking for annexation were filed with the Minnesota Municipal Commission, and the Mankato Township Board, and the Blue Earth County Board, and that more than thirty days have elapsed since said filing and that no objections to said annexation were submitted.


III.

The City of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tract and parcel of land is so conditioned as properly to be subjected to city government and is hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota, are hereby extended to include said property.

The City Clerk is hereby directed to file certified copy of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon filing of certified copies, as herein described.
