ORDINANCE NO. 98

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF FOLEY TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJACENT UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated September 11th, 1966, requesting annexation of the territory hereinafter described was duly presented to the council on the 14th day of September, 1966; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than one-half acre of platted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all the owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits at the westerly boundary thereof;

THE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, ORDAINS:

Section 1. That the village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

The East ninety (90) feet of the West Half (W1/2) of Lot numbered Eleven (11) of Auditor's Plat of Subdivision of part of the Southeast Quarter of the Southwest Quarter (SW1/4 of SW1/4) of Section Twenty-six (26), Township Thirty-seven (37), Range Twenty-nine (29), otherwise described as: Beginning 33 feet north and 020.0 feet west of the quarter corner of the south line of Section 26, Township 37, Range 29; thence west 90 feet; thence north at right angles 200 feet; thence east at right angles 90 feet; thence south at right angles 200 feet to the place of beginning, which is of record in the offices of William J. Sarge and Rita M. Sarge, husband and wife.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Corporation, the Secretary of State and the County Auditor.

Section 4. Effective date. This ordinance takes effect upon its passage and publication and the filing of three certified copies as directed in Section 3.

Adopted by the council this 7th day of December, 1966.
