ORDINANCE NO. 321

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

The Common Council of the City of Marshall do ordain as follows:

Section 1. A petition has been filed with the Common Council of the City of Marshall, Minnesota by the sole owner of the following described real estate in the County of Lyon, State of Minnesota, to have such land included within the City of Marshall, Minnesota:

All that part of the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 3, Township 111 North, Range 41 West of the Fifth Principal Meridian, Lyon County, Minnesota, described as follows:

Commencing at a point on the south right-of-way line of State Trunk Highway No. 19 constructed and maintained through said Section 3, which is 1,122 feet east of the west quarter corner of said Section 3 and 50 feet south of the center line of said State Trunk Highway, thence southerly at right angles to said right-of-way line 175 feet to point of beginning, thence southerly and at right angles to said right-of-way line 65 feet, thence westerly and parallel to said right-of-way line 150 feet, thence northerly at right angles to said right-of-way line 65 feet, thence easterly and parallel to said right-of-way line 150 feet to point of beginning, containing 0.22 acres, more or less.

Section 2. The quantity of land embraced within the foregoing description and bounded as described is 0.22 acres, more or less.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interests of the City of Marshall, Minnesota, and of the territory affected; and (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subject to City government.

Section 4. Therefore, the City of Marshall, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Marshall, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.




