AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ALBANY TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LANDS, THE EXTENDED 200 ACRES IN AREA, ADJACENT WITH THE VILLAGE LIMITS.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on the 10th day of September, 1955, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than 200 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough, and

WHEREAS, the petition was signed by 11 electors, constituting a majority but not all of the total number of 16 electors; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was duly held by the governing body of the Village of Albany, Wisconsin, on the proposed annexation after at least 30 days posted notice; and

WHEREAS, the land described in the petition abuts upon the Village limits at the easterly and westerly boundaries thereof;

The Council of the Village of Albany, Wisconsin ordains:

Section 1. The Village Council hereby determines

(a). that the annexation will be to the best interests of the Village and of the territory affected;

(b). that the territory described herein abuts upon the Village limits and is about to become urban or suburban in character; and

(c.) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory annexed. The corporate limits of the Village of Albany are hereby extended to include the unplatted lands described as follows and the same are hereby annexed to and included within the Village as effectively as if it had been originally a part thereof:

That part of the South Half (SH) of Section Sixteen (16) lying southerly of the Great Northern Railway Company's right of way and lying northerly of the southerly line of United States Highway No. 52 (Interstate Highway # 94), excepting therefrom the northerly 205 feet of the south-west quarter of the Southeast quarter (SW/4) of Section Sixteen (16); also that part of the Northwest quarter of the Northeast quarter (NW/4) of Section Twenty-one (21) lying northerly of the southerly line of United States Highway No. 52; also all of the northeast quarter of the southeast quarter (NE/4) of Section Twenty-one (21) except that part thereof heretofore annexed to the Village of Albany, all of the above being part of Township One Hundred Twenty Five (125), North of Range Thirty-one (31) West, Hennepin County, Minnesota.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
