ORIGINATOR NO. 6.

AN ORDERING ESTABLISHING THE COUNCIL LINES OF THE VILLAGE OF ALBANY TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LANDS, AND EXCLUDING 250 ACRES IN AREA, ABSTACT FROM THE VILLAGE LINES.

WHEREAS, a certain petition requesting annexation of the territory hereinbefore described was duly presented to the Council on the 10th day of September, 1905, and WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than 250 acres of unplattd land, no part of which is included within the limits of an incorporated city, village, or borough, and

WHEREAS, the petition was signed by 23 citizens, constituting a majority but not all of the total number of 30 citizens and

WHEREAS, no objection to the annexation have been received from the Town Board, the County Court, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a meeting was duly held by the governing body of the Village of Albany, Monroe, on the proposed annexation after at least 30 days posted notices; and

WHEREAS, the land described in the petition abuts upon the Village limits at the easterly and westerly boundaries thereof;

The Council of the Village of Albany, Monroe, ordains:

Section 1. The Village Council hereby determines

(a). That the annexation will be to the best interests of the Village and of the territory affected;

(b). that the territory described herein above upon the Village limits and so close to become water or ground in character; and

(c.) that parts of said territory as now included within the limits of any city, village, or town,

Section 2. Boundary lines. The proposed lines of the Village of Albany are hereby ordered to include the unplattd lands described as follows and the same to hereby annex to and be joined with the Village so effectually as if it had been originally a part thereof.

That part of the South Half (2<sup>1</sup>/2) of Section Sixteen (16) lying southerly of the Great Northern Railway Company's right of way and lying northerly of the southerly line of United States Highway No. 52 (Minnesota Highway 794), excepting therefrom the northeasterly 225 feet of the southwesterly quarter of the Southeast quarter (1/4 of 16<sup>1</sup>) of Section Sixteen (16); also that part of the northeast quarter of the Northwest quarter (1/4 of 16<sup>1</sup>) of Section Twenty-one (21) lying northerly of the southerly line of United States Highway No. 52; also all of the northeasterly quarter of the northeasterly quarter (1/16<sup>1</sup>) of Section Twenty-one (21) except that part thereof heretofore annexed to the Village of Albany, all of the above being part of Township One Hundred Sixty Five (165), North of Range Thirteen (13) West, Minnesota County, Minnesota.

Section 3. Miller. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
